In continuation of Public Notice No. 052-BOPEE of 2017 dated 03-07-2017 and on the basis of list of sports Category candidates forwarded by the J&K Sports Council vide letter No. SC/491-Poly/3006-07 dated 30-06-2017, the merit list of candidates, whose names are available with the Board and also recommended by the J&K Sports Council forms Annexure 'A' to this Notification. 2. Any candidate(s) is/are at liberty to make representations against the position assigned to him/her or any other candidate under Sports Category within three working days from the date of issue of this Notification i.e. up to 21<sup>st</sup> July, 2017 (4.00 pm).
3. The candidates at S. No. 25 and 30 of Annexure 'B' are allowed to present themselves at BOPEE office Jammu/Srinagar within two days i.e. up to 22<sup>nd</sup> July, 2017 along with original documents and photocopies of the same for verification by the Board, as they fall within the Cut off merit determined for the sports category candidates.

This Sports list is only for determination of eligibility under Sports Category and shall not be determinative of allocation of seats to such candidates on the basis of Sports Category but shall be only on the basis of merit in NEET (UG), 2017 in accordance with the rules.
